## PANGAGGUJINIQ (NUNAVUT QUEST) DOG SLED RACE

The Pangaggujiniq dog sled race was first held in 1999 to celebrate the creation of Nunavut. Each year since then, teams of ten to twelve dogs pulling qamutik (sleds) race between different communities in the North Baffin Island region. This year nine teams raced the 395 kilometers from Igloolik to Pond Inlet, the host community. As well as facing a challenging terrain that varied from rough pack ice along the coastline to deep soft snow in the valleys, racers were always on the lookout for polar bears. The foundation was pleased to contribute to an exciting event that has sparked a renewed interest in this traditional mode of travel and an increase in the number of dog teams in the participating communities.
